To judge by its tax and benefits policies, one would have to conclude that this Government wished to discourage traditional, two-parent family life.

Motoring

A report written by former welfare reform minister Frank Field, published today by the independent think-tank Reform, reveals, in genuinely shocking terms, the degree of official economic discrimination against two-parent families.

The figures are stark and astonishing: because of the huge bias in favour of single parenthood that prevails in the tax credit system, a single mother with two children under the age of 11 who works 16 hours a week on the minimum wage, receives, largely thanks to tax credits, an income of £487.

advertisement A two-parent family, on the other hand, also with two children under 11, in which either one or both partners works for the minimum wage, would have to put in a total of 116 hours a week to take home the same income.

As a result, Mr Field points out, the risk of poverty has scarcely changed for children in twoparent families, who have been systematically neglected in the Government's campaign to eliminate child poverty.

Bizarrely for a governing party that has advocated personal responsibility and the virtues of stable family life, Labour has chosen to victimise precisely those children who are being raised in what might be thought to be the most secure domestic environments.

In effect, unmarried women with children are being bribed to remain single, while existing two-parent families are penalised.

By a striking coincidence, the Home Office announcement yesterday of its new policy on paedophiles points up another dimension to the problem of the breakdown in traditional family patterns.

The Home Secretary, John Reid, proposed granting single mothers entering into a new relationship with a man the right to check his past record for sex offences.

This is, in effect, an acknowledgment of the fact that a single mother's new male partner is statistically the most likely perpetrator of child abuse. The Government, having encouraged single parenthood, is now having to deal with one of its consequences.
